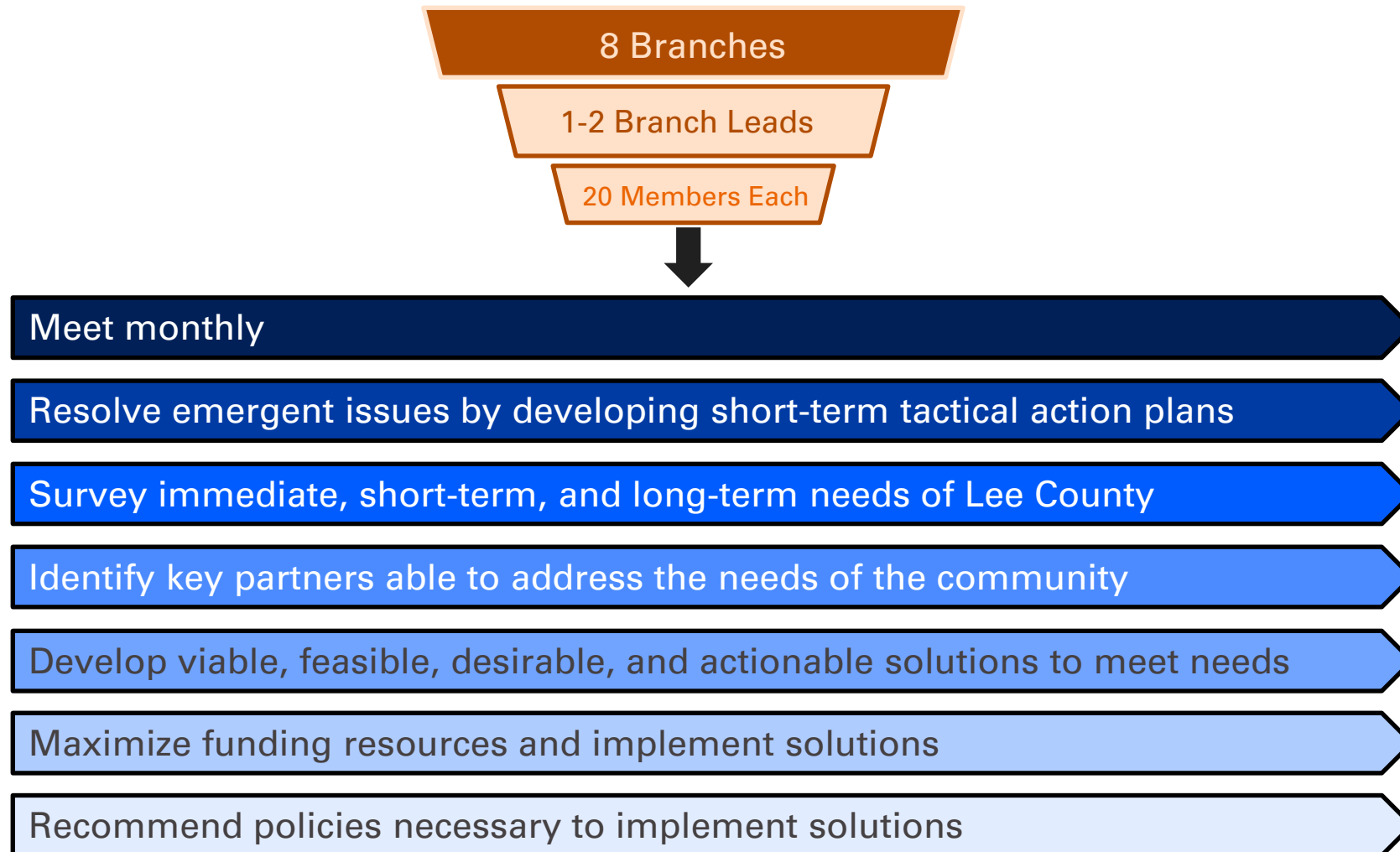

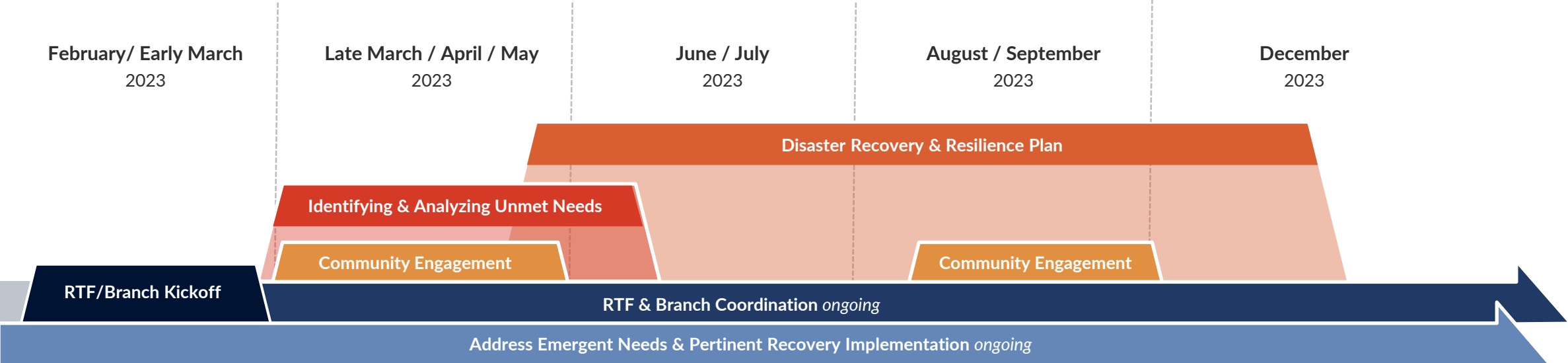

RTF Structure: Branches



High Level Process for Long-term Recovery Planning



RTF / Branch Kickoff

Establish the working structure for RTF and launch branches. Identify immediate needs and goals to address.

Launch website.

RTF & Branch Coordination

Identify recovery objectives; inform impact and needs assessment; establish projects; incorporate community's priorities; inform long term planning; oversee recovery plan implementation.

Identifying & Analyzing Unmet Needs

Hurricane Ian storm impact analysis, and a cursory look at outstanding needs that will begin to shape recovery priorities.

Community Engagement*

Comprehensive community outreach to inform and validate needs, identify solutions, and validate planning.

Hurricane Ian Disaster Recovery & Resilience Plan

A framework for Lee County's recovery from Hurricane Ian, including prioritized projects, funding sources, and key stakeholders.

Emergent Needs & Pertinent Recovery Implementation

Conduct recovery operations and manage recovery funding streams: short-term, intermediate, long-term.

RTF is forum to identify emergent and time sensitive needs and identifying best path forward.

Branch members **understand their commitment** to the development of the Lee County Long-Term Recovery and Resilience Plan

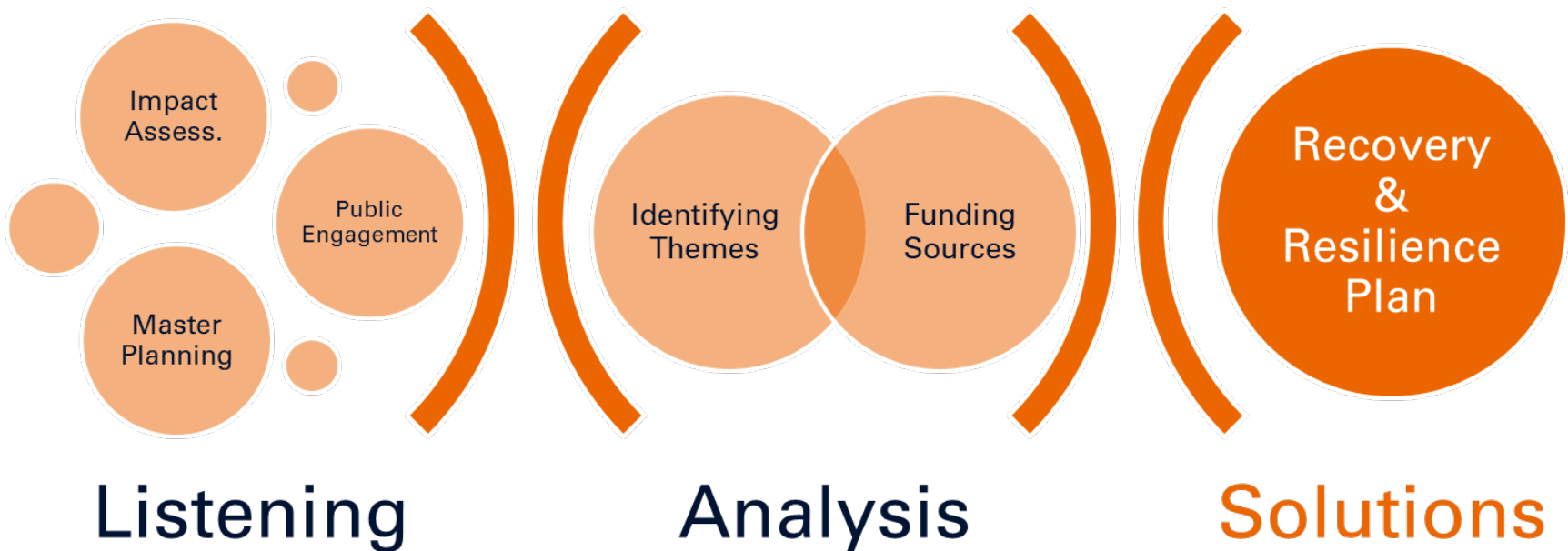


Branch objectives align under the current **direction of the Recovery Task Force**

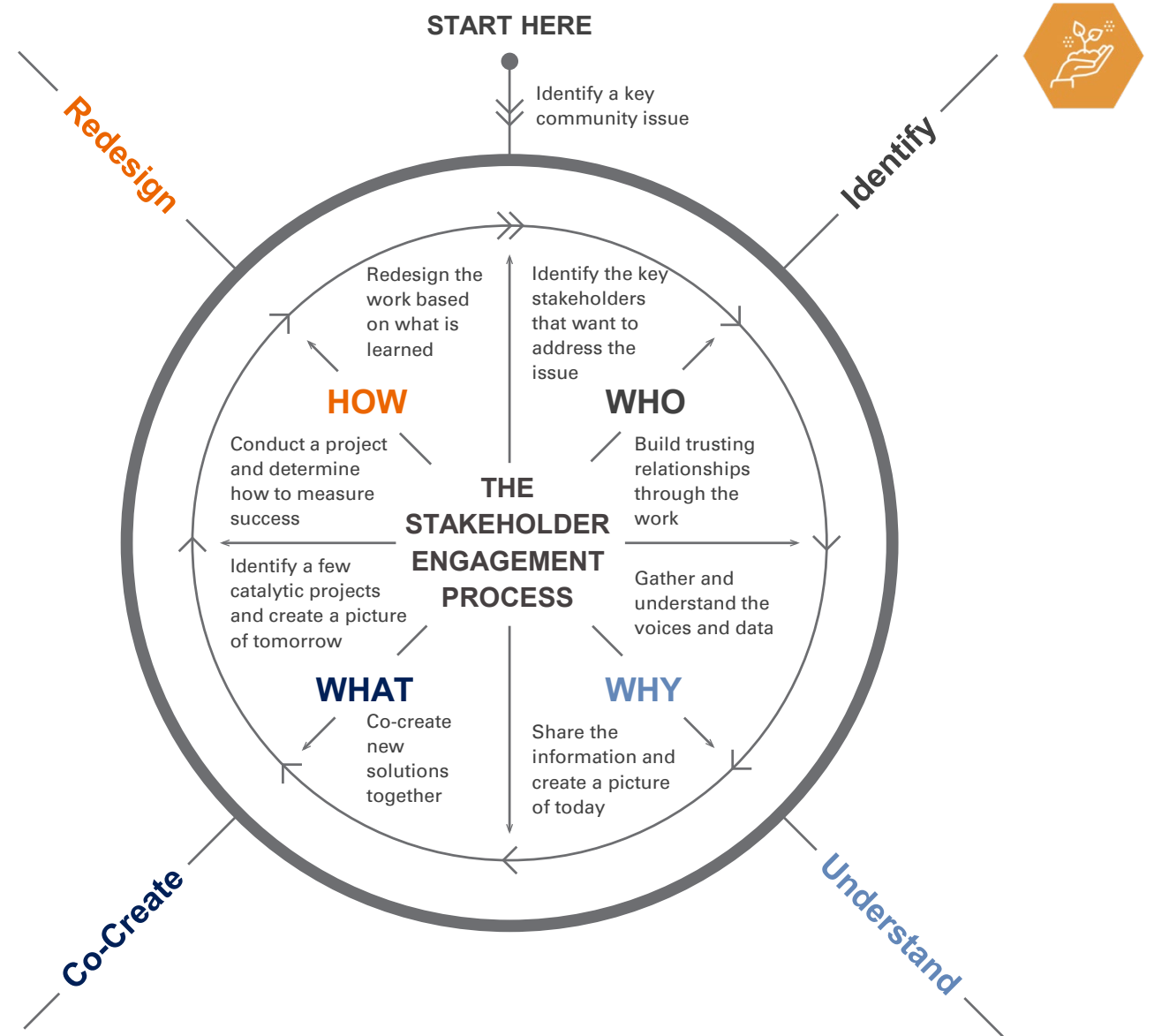

To date, there have been 1,486 responses to the survey.

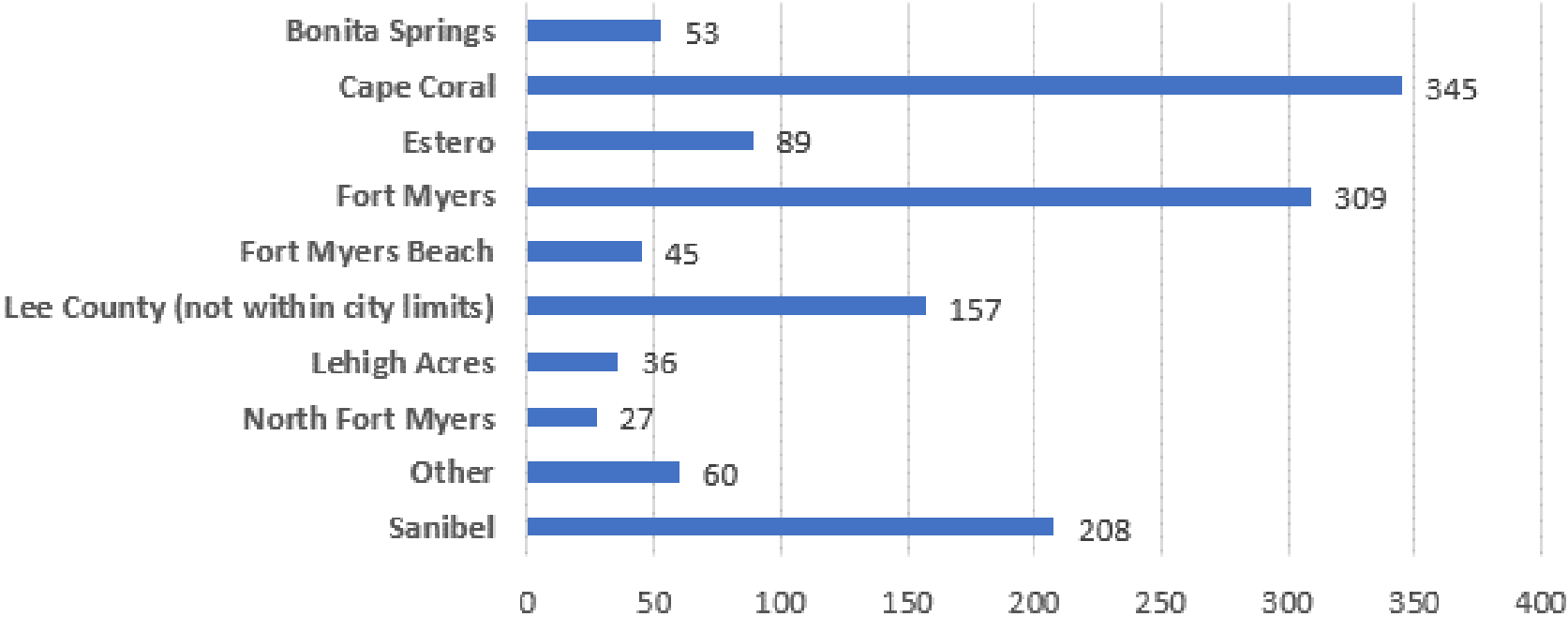
The top 5 priorities for Lee County residents:

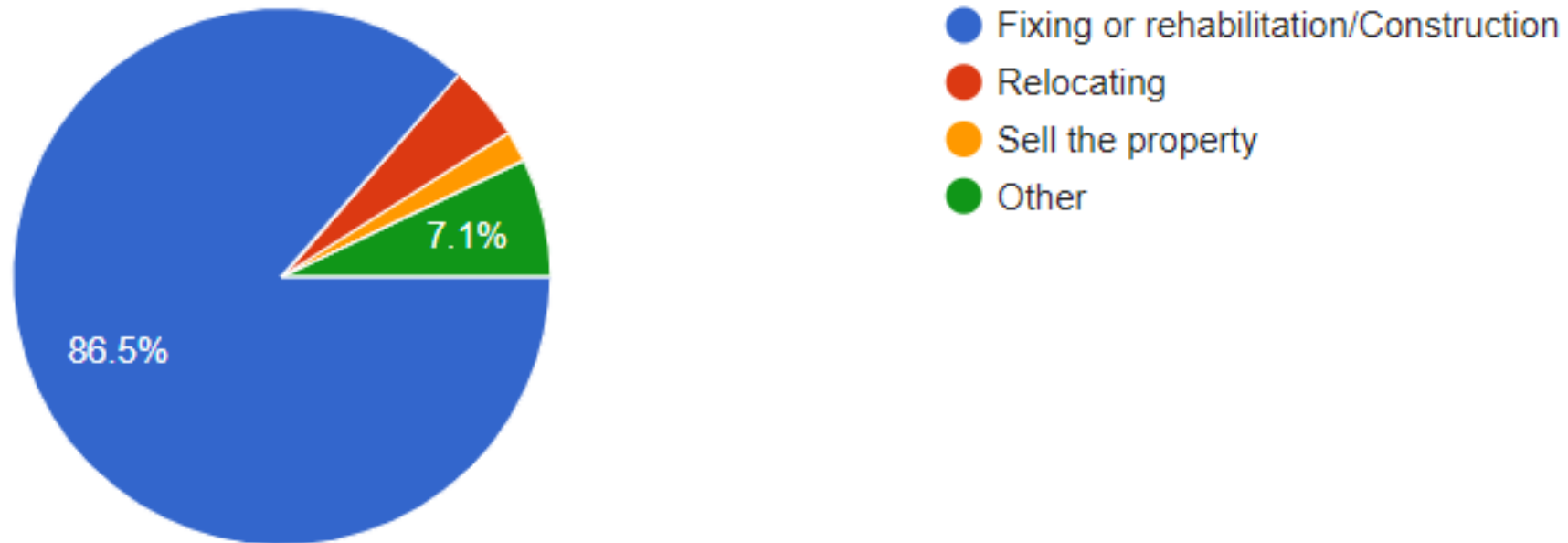
Where do respondents reside?

- Sidewalks and better drainage in Morse Shores, The Shores, and River Forest

- Eliminate filling wetlands and allowing developers to create wetlands elsewhere
- Integration with natural surrounding
- Replant Mangroves

Branch Action Plan



Purpose:

- Branches will develop an Action Plan as an initial step in framing identified and approved initiatives.

The Action Plan will:

- Provide a prioritization framework for existing plans and projects;
- Illustrate the planned approach for new initiatives; and
- Identify key policy changes that can support community resilience.



Branch Member Responsibilities



- Branches will need to accomplish the following to successfully develop an action plan:
 - Deliberate best approaches to addressing priorities;
 - Identify and collaborate with key partners/stakeholders who might implement initiatives or enact policy changes; and
 - Participate in workshops related to Branch priorities/initiatives.
- Branch members are responsible for facilitating the design (concept and approach) of the initiatives and identifying a lead to facilitate initiative implementation.
- Branches will need to identify the following elements of initiatives:
 - **Lead**
 - **Initiative Description and Progress**
 - **Measures of Success**
 - **Partners**



Branches may also assist in determining initiative Implementation Steps as needed.



What is an Initiative?

- An initiative constitutes the plan of action each Branch has selected, with support from the Recovery Task Force, to address validated priority areas.
- Initiatives are the critical piece of the Recovery and Resiliency Plan that will showcase the steps Lee County is taking to increase overall resiliency.

How to Read an Initiative:



Lead

The lead represents the primary organization or position charged with overseeing the action's implementation.

Initiative Description + Progress

The description provides a high-level overview of each action that explains its purpose in the Recovery Action Plan.

Funding

Potential funding or organizations with potential funding are listed here.

Resources

The resources are identified information, guidance, and/or equipment necessary to support implementation.

Where is this Initiative Involved?

Connections to relevant planning documents are noted in this section.

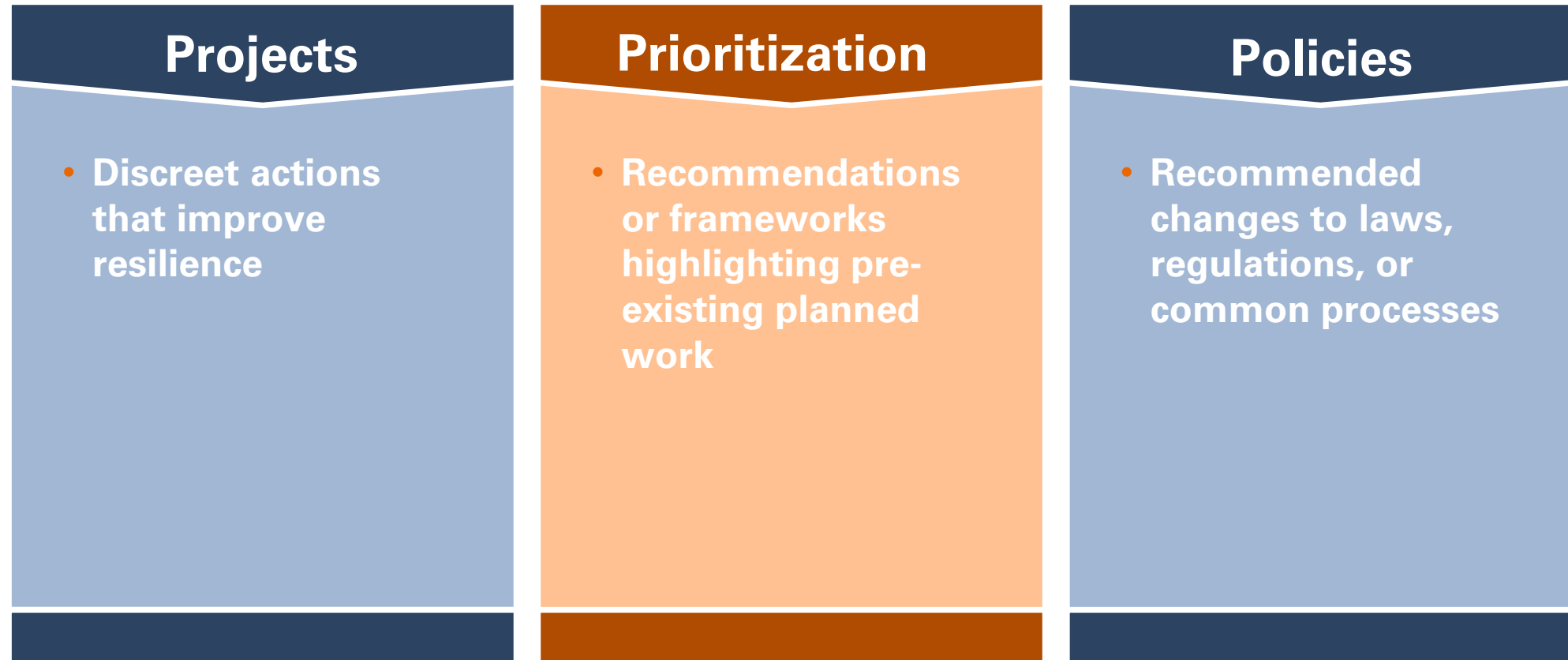

The Special Role of the Planning & Capacity Branch



Developing a Resilience “Overlay”

- The Planning & Capacity Branch have identified a technique for improving resilience at the policy level through developing an overlay. A resilience overlay is a tool used to:
 - Identify and address potential risks and hazards in a specific geographic area or in relation to a specific plan or set of plans; and
 - Communicate priorities across planning processes and budget development.
- Overlays often identify and visualize potential risk areas in advance to reduce disaster impacts.
- Additionally, overlays map areas that are at risk of natural disasters such as floods, wildfires, and hurricanes.
 - Other risks are sometimes mapped including infrastructure failure risk areas and economically vulnerable areas.
- Zoning and building codes can be modified to improve resiliency based on these overlays.

Takeaway: This Branch should communicate policy – related recommendations to the Planning and Capacity Branch

Workshop Design



What is a Workshop?

- Workshops will give branch members the opportunity to meet with partners that may support, lead, or collaborate on the development of Branch initiatives.
- The workshops are expected to take place over 4 days, with a different theme covered each day.
- **Branch members can attend any workshop as themes and topics intersect across branches.**

Workshop Themes

- Workshops will be categorized by intersecting themes among branches including:
 - **Attainable and Resilient Workforce Housing;**
 - **Critical Infrastructure;**
 - **Community Resilience; and**
 - **Supporting Business and Workforce.**



Attainable and Resilient Housing



Topics

- Reducing or offsetting the impact of fees and other development costs to support the production of multi-unit, attainable housing.
- Incentivizing developers to produce attainable, multi-unit housing near centers of employment.
- Innovative policy approaches including community land trusts and accessory dwelling units to create more affordable housing.

Critical Infrastructure



Topics

- Prioritizing critical facilities for resilience upgrades and hardening.
- Identifying the infrastructure (water and power) projects that would provide the greatest resilience value in defending key infrastructure assets.
- Protecting, restoring and enhancing natural resources supporting health and resilience.
- How to best ensure Lee County has resilient supportive physical infrastructure - roads, highways, fuel and transport.

Critical Infrastructure

- Making arts and culture institutions a more formal part of the effort to reliably provide disaster response services and potentially receive funding.

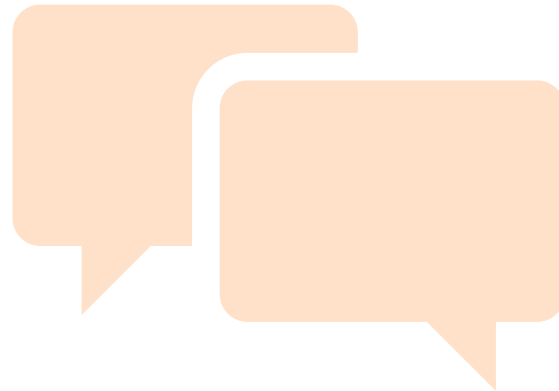
