



RTF / Branch Kickoff

Establish the working structure for RTF and launch branches. Identify immediate needs and goals to address.

Launch website.

RTF & Branch Coordination

Identify recovery objectives; inform impact and needs assessment: establish projects; incorporate community's priorities; inform long term planning; oversee recovery plan implementation.

Identifying & Analyzing Unmet Needs

Hurricane Ian storm impact analysis, and a cursory look at outstanding needs that will begin to shape recovery priorities.

Community **Engagement**

Comprehensive community outreach to inform and validate needs. identify solutions, and validate planning.

Hurricane lan **Disaster Recovery** & Resilience Plan

A framework for Lee County's recovery from Hurricane lan, including prioritized projects, funding sources, and key stakeholders.

Emergent Needs & Pertinent Recovery Implementation

Conduct recovery operations and manage recovery funding streams: short-term, intermediate, long-term.

RTF is forum to identify emergent and time sensitive needs and identifying best path forward.

Overview of Recent Recovery Task Force Efforts



- Recent strategic pause to address feedback from a multitude of stakeholders and align draft Initiative Profiles with feedback and perspectives from the County Administration.
 - Hosted a series of one-on-one meetings between the ResilientLee Support Team's Lead Subject Matter Expert and Subject Matter Experts from the County Administration to review the draft Initiative Profiles for all eight Branches.
- Executed five regularly scheduled Branch Meetings in August and three outstanding meetings in September to review current draft Initiative Profiles.
 - Following recent Branch meetings, circulated an online Survey Form to Branch Members requesting their additional feedback to current draft Initiative Profiles.

Suggestion to change the title of the Initiative Profile to "skills-based hiring."		 Suggest a formal or informal coordination structure. Consider barriers to upskilling, wrap-around services available, and economic mobility.



E&W02: Resilient Economy

 This Initiative Profile could fall under the Economic Recovery Branch. Note that Cape Coral is working on a program that supports this. 	·	 Recommend including the Florida Gulf Coast University Business Survey to determine at-home workers and workforce Consideration: Identify smart programs that can reach businesses to get both at home and in person workforce in the door.



E&W03: Lifelong Learning

 People may not know the meaning of microcredentialing and that it is non-traditional, yet flexible, way to adapt to the changing conditions of the workforce. Suggestion for communicating how the programs work and why they are in place. Create a model of at-work training. 	Include financial literacy and education for individuals and families.	 Existing context: A new technical college from Miami moved to Lee County and successfully supports Spanish speaking individuals and trades. Suggest including the larger need for technical college and a regional approach to trades and the workforce.



E&W04: Early Learning



Branch Feedback	RTF Feedback	County Feedback
 Incentivize the improvement and expansion of existing quality childcare programs and centers and the start of new centers in partnership with businesses, nonprofits, and faith organizations. This can be done by creating a Start Up packet with basic information and a start up grant for some upfront costs to beginning a center. 	 Address the need to increase the quality of early learning by sharing pre-kindergarten standards. Provide families with resources about available programs and the importance of kindergarten readiness. Incentivize expanding existing and new programs/centers in partnership with businesses, non-profits, and faith organizations. 	 Recommendation: A regional approach could include building multi purpose facilities or a regional node for services. Suggest working with the school district and connecting this Initiative to resilience.



E&W05: Out of School Programming

		 Conduct an assessment on younger generation lower workforce participation rates and identify what incentives are needed. Recommend combining with E&W08.



E&W06: School to Career Programs

	 Partner organizations with employers to provide job training, especially to individuals with developmental disabilities. 	 Context to consider: Schools are embedded with career programs and good connections to industries. The need is for better coordination and communication of what is available.

	 Include Lee Health and Kids Minds Matter as partners. 	



E&W08: Literacy Programs

Consider language learning in measures of success.	Appropriate data collection can identify the most effective areas for literacy implementation.	Supportive of public private partnerships for technology and literacy for kids.



E&W09: Education and Mental Health

 Increase mental health providers. Add Park Royal and LeeHealth partners. 	 Establish a navigator model to connect people to mental health services. Partner with Kids Minds Matter or Care Solace Calming the Chaos of Mental Health Care. 	 Context to consider: Franklin Park Elementary School offers a program of wrap around services. Supportive of Lee Health and the School District working on this.

Draft Initiative Profile Development:


- The Support Team will continue:
